ZONE 8 ~ REGIONALSATION

Proposed Regional Structure:

All districts in Australia, New Zealand and the Pacific Islands would be placed within a region governed by a Regional Council that would manage all regional operations with the assistance of vibrant Regional Support Committees. The role of the Regional Council would be to manage the day-to-day activities of the region, including setting membership dues and governing all aspects of Rotary currently managed by districts. Each region would then be divided into sections or areas, with 10-30 Rotary and Rotaract clubs within each.

The Regional Strategic Goal is to establish a Regional Governance structure to transform Rotary and Rotaract in our region, to better support Clubs to pro-

vide relevant and engaging experiences, that serve our communities and enable us to grow.

President Reg advised our Club that time is limited, so, we need to think about: Regional Council, Regional Specialists and Rotary's Place today. In the future, there will be no Assistant Governors. Issues will be Zone-wise not dependent on the US. A new level of Governance and type of support will be in place..



ZONE 8 REGIONALSATION cont.

Here are some guiding questions :

How do we group Clubs? By their location or geography? What type of Club do we want and what are their common features? Each Rotary Group will elect their own 'leader' and will facilitate growth and provide support. So how do we want to be grouped? Each Club will select the its preference based on majority decision . What are we passionate about? What are our strengths and Weaknesses? How would any support help us as a Club? What is our preferred grouping?

Are we interested in being part (subset) of a secondary grouping?

There were many areas to consider which we diligently did by consensus of three options:

The top three passionate issues for Howrah Club were **Protecting the environment / Support education / Fighting disease.** Other areas provided a healthy discussion but remain simmering in the background. These were deemed as important but main focus on the ones above.

Our Club's strengths: Membership participation – Community recognition – Camaraderie and friendship.

Our Greatest Challenge: Technology and social media ~ Rejuvenating our Club.

Grouping: State of Tasmania as ONE GROUP.

Secondary: How small do we need or want to be?
